Spay/Neuter & Vaccinations - our programs provide free and low cost spay/neuter surgeries and vaccinations for unaltered pets belonging to low-income Dallas residents. These programs include 2-3 times a month high quality, high volume spay/neuter clinics as well as periodic vaccination clinics. Spay/neuter reduces the number of unwanted pets born each year - a critical component in reducing the number of homeless pets euthanized. The program revenue is for low cost spay/neuter, microchips, heartworm tests, flea/heartworm prevention and other medicines

Pet Placement Support - we serve as a "Friends of Dallas Animal Services" for the city of Dallas municipal shelter, assisting with fundraising for equipment, services, and supplies over and above what it provided by the city of Dallas. We also provide volunteer manpower to enhance and expand shelter operations.

Community Outreach - our outreach program includes providing pet food and resources for homeless and low income pet owners served through the Crossroads Community Center in downtown Dallas; The Lucy Fund which provides emergency veterinary care for ill or injured animals whose owners are unable to afford treatment; and the Pets For Life program, a targeted outreach program that embraces the human component of the human-animal equation by approaching in a respectful, non-judgemental way, no matter what their socio-economic circumstances or cultural differences may be. This program offers services such as vaccinations, spay/neuter, fence building, veterinary medical assistance and much more.
